## Mandated Reporting Laws

Over the past two decades, increased attention and legislation has focused on the issue of child abuse and neglect, a complex and nation-wide problem. Fortunately, over the past several years, legislators have been examining laws and many states, including Ohio, have changed laws to reflect a more curative, compassionate, and humanistic approach.

As a day care owner, instructor, teacher or aide you should be aware of the **Mandated Reporting Law (ORC 2151.421)** for suspected child abuse and neglect in the state of Ohio.

Ohio Department of Job and Family Services requires specific training Seminars in the areas of CHILD ABUSE AND NEGLECT (ODJFS 5101: 2-12-27).

The State requires an **initial 6-hour training** course and then a **3-hour refresher** course every three years after the initial 6-hour training.

**NOTE:** Mahoning County Children Services provides both Training Seminars as a *complimentary* service to our community including individuals who either reside or work in Mahoning County.



## Training Topics

Topics include but are not limited to: identification, reporting, and treatment of abused and neglected children and their families. The training will also focus on the different types of child abuse, the signs and symptoms of abuse and neglect, appropriate agency procedures, protocols, and preventative efforts that day cares and pre-schools can implement.

**This Training Seminar provides both the Initial and Review courses at the same time.**

- The Half-day Review Training (3-hours) ends at Noon.
- The All-day Initial Training (6-hours) continues after lunch.
- The Review 3-hour Course is open only to those persons who have completed the 6-hour Initial Training (or a 3-hour review) within the past three years.

**NOTE:** You may be required to submit proof of completion for both of these courses to your state licensing department.
