Suitcases, Tote bags Donated for Kids

T&T Pioneers, a network of active and retired employees from the Youngstown Chapter presented 100 overnight suitcases to Mahoning County Children Services for children who are placed in foster care. "AT&T Pioneers in Youngstown realize how precious our children are and saw an opportunity to make their world a little better," states Steve Kristan, AT&T Director of External and Legislative Affairs.

The idea to provide suitcases and tote bags was a much needed and creative solution that many agencies adopted nationally to combat placing children's belongings in plastic trash bags when they are placed in foster care.

The Canfield, Ohio Girl Scout Troop #80174 also donated backpack totes. The donated suitcases and totes contain a blanket, stuffed animal and toothbrush kits. When children are placed in foster care, many arrive on short notice and with only the clothing they're wearing. Often, their belongings are placed in plastic bags or trash bags. The suitcases and overnight bags include personal items such as blankets, toiletries, and a plush toy or stuffed animal to cuddle, which helps comfort and ease the child's transition to a foster home especially at a time when a child feels most vulnerable.


