RULE REVIEW

Rule 5101:2-7-12 | Site and safety requirements for a foster home.

(H) A foster home shall comply with the following requirements regarding weapons:

- (1) The following weapons kept on the grounds of or in a foster home shall be stored in an inoperative condition, in a locked area, and are to be inaccessible to children:
 - (a) <u>Firearms</u>.
 - (b) Air rifles.
 - (c) <u>Hunting slingshots</u>.
 - (d) Any other projectile weapon.
- (2) <u>All ammunition</u>, arrows or projectiles for such weapons shall be <u>stored in a separate locked space</u> from the firearm, air rifle, hunting sling shots or any other projectile weapon.
- (3) Any foster caregiver who is also a law enforcement official and can document that their jurisdiction requires them to have ready and immediate access to their weapon shall be exempt from the requirements of this paragraph.

Rule 5101:2-7-02 General requirements for foster caregivers and applicants.

(G) An applicant or household member may be required to secure and provide a report, in addition to the JFS 01653-Medical Statement For Foster Caregiver/Adoption Applicant and All Household Members, of an examination of any member of the household by a licensed physician, psychologist, or other certified or licensed professional if either of the following are applicable:

- (1) An applicant or any person residing within the household has suffered a serious illness or injury within the past year.
- (2) The recommending agency determines it to be necessary to ensure the safety, health, or care of any foster child who may be placed in the home.

(H) Homes certified prior to June 1, 2020 do not have to comply with immunization requirements.

(I) Immunizations for homes certified on or after June 1, 2020.

- (1) All children who are household members are to be up to date on immunizations consistent with the recommendations of the American academy of pediatrics, the advisory committee on immunization practices of the centers for disease control and prevention, and the American academy of family physicians unless the immunization is contrary to the child's health as documented by a licensed health care professional or for reasons of conscience, including religious convictions.
- (2) All household members in a home caring for infants and children with special medical needs are to have an annual influenza vaccine consistent with the recommendations of the advisory committee on immunization practices (ACIP) unless the immunization is contrary to the individual's health as documented by a licensed health care professional or for reasons of conscience, including religious convictions.
- (3) All household members in a home caring for infants are to be up to date on the pertussis vaccine unless the immunization is contrary to the individual's health as documented by a licensed health care professional or for reasons of conscience, including religious convictions.

(4) Copies of the immunization records are to be placed in the file of the home.

Rule 5101:2-7-02 was amended on June 15, 2020 to reflect these rule changes.

SHOUT OUTS

Shout Out to the Huddleston family for not only taking an emergency placement of a sibling group when they were not even on the emergency list to begin with, but also for driving to the hospital to pick up the children to relieve an on call worker who had been up all night with on one to care for the children.


AGENCY POLICY

Foster Caregiver I.D. Card

The Health and Safety Committee is implementing an I.D. card program for Foster Caregivers at Mahoning County Children Services.

Foster Caregivers please send a clear picture/head shot via email to Sandy @ Sandy.Appel@jfs.ohio.gov

Example: Your picture and name will be in the right upper corner on the card.



Foster Caregivers please keep this I.D. card on you at all times. The I.D. cards will be used when foster caregivers are transporting child in agency custody, visitation at the office or Hope House, meetings, medical appointments and/or medical emergencies.

Once the card is created you can either sign the card at your next visit to The Agency or your worker will bring it at her next home visit.

After the signature is received, the card will be laminated, placed in a CSB lanyard, and returned.



EMERGENCY LIST REMINDERS

Important things to remember when you are on the Emergency List or are considering becoming an Emergency Placement:

- Must answer the phone or return call to the agency representatives
- Must notify agency immediately if you are not able to continue to be on the Emergency Placement List
- Must take children sight unseen. A gentle reminder when you are on emergency, take whatever steps you feel necessary to be sure you hear your phone all times day and night. While we realize everyone is busy, it is important to know we are trying to get a child to the safest placement as quickly as possible, not answering the phone or by saying "no", you are impeding the placement of a child.
- Placements are often made in the dark. Be sure your house is well lit and marked to make it easier for workers to find.
- Reimbursement for an emergency placement is \$60 per day for the first 30 days. After 30 days, it goes to the regular daily rate.
- Have car seats and beds available for children you are agreeing to accept on emergency.

CPR / FIRST AID TRAINING

CPR/FIRST AID Requirement

Remember to register for adult/infant/child CPR and First Aid once every recertification period. This is a COA requirement for your foster care license.

You may access these classes online at the American Heart Association/American Red Cross or contact your licensing worker for more information.

All CPR/First Aid training must be an in person training. No CPR/Fist Aid cards will be accepted from an online training.



AGENCY PROVIDERS

The attached flyer from Cadence Care outlines services now being offered to our foster and kinship caregivers through a collaborative with the agency. How Do I Get The Child(ren) In My Home Involved:

 Let your child's MCCS Caseworker know that you are interested

OR

 Call 330-544-8005, extension 1101 Monday-Friday 8:30am-4:30 PM and ask about the Mahoning County Collaborative Program Cadence Care Network is teaming up with Mahoning County Children Services to provide family-centered supportive services for children placed in foster homes and kinship homes

We Provide:

- Trauma-informed activities to help with the child's adjustment during everyday life and transition periods such as moving between homes, family visits and other major life changes
- We meet the child and family at any location (home, school, community)
- Goal-oriented treatment
- Linkage to community resources
- Supportive services to caregivers:
 - Access to after-hour and weekend crisis support
 - In home sessions
 - Parent centered interventions such as Triple P Parenting and trauma education to help the children in your home be successful



IMPORTANT ONGOING TRAINING INFORMATION

Training is very important to ongoing foster parents. Because of this, the agency strives to bring you as many relevant and informative trainings as possible. Our training schedule is set by the regional offices and the expectation is we will have at least 8 participants at every training. Previous trainings have had to be cancelled due to lack of participants. Please try to attend if possible.

Please park in the garage underneath the building. The entrance for the parking lot/garage is on W.
Commerce St. which is behind MCCS. Enter the lot after waiting patiently for the parking arm to raise. Drive through the lot and park in the parking garage. Enter the building through the doors on your left (non-employee doors). Take the elevator to the third floor for training. Do not park on Federal St. or try to enter from the front doors on Federal St. as these doors remain locked afterhours. The parking garage will close 15 minutes after the start of training. Reminder sometimes it can be chilly in the training room, so you may want to bring a sweater or sweatshirt. Please dress comfortably.

Please bring a mask as some trainers may require masks being worn during training.

TRAINING REMINDER

Please make sure when you attend a training to sign in and name the agency/county where you are from, otherwise, you may not get credit

REMINDER PLEASE DO NOT BRING CHILDREN TO TRAININGS

You can earn up to 3 credit hours for reading a book; however; you must contact your licensing worker for a book review outline that is required for training credit. You can also earn 3 training hours by watching *Despicable Me, Juno, Like Dandelion Dust* or *Meet the Robinsons* and completing the movie guide. You can contact your licensing worker about getting the movie guide. Movies can be rented from your local video store, Redbox, Netflix or your local library.

SIPS ask your licensing worker for SIPS. These are supplements to help with completion of a minimal amount of training hours. Each SIPS can only be completed once.

Webinars are also a great way to get your hours. Akron Children's Hospital offers many informative webinars regarding children's health issues. Please note you can earn up to 12 hours in a 2 year time frame by reading a book, watching a movie, doing SIPS, or going online.

Please remember that your 30 hours of ongoing training is due *no later than 30 days* prior to your license expiration date.
