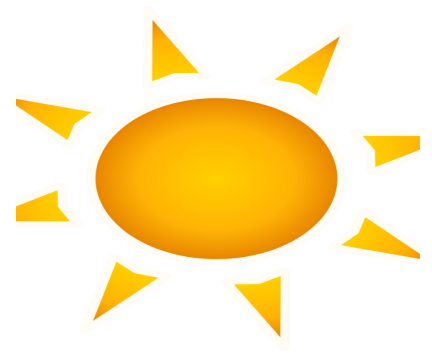

## RULE REVIEW

### **Rule 5101:2-7-12 | Site and safety requirements for a foster home.**

A) A foster home and all structures on the grounds of the home shall be maintained in a clean, safe, and sanitary condition and in a reasonable state of repair. A home shall be a house, mobile home, housing unit or apartment occupied by an individual or a family.

(1) A home is to be free of peeling or chipping paint.

(2) If a potential lead hazard is identified, the recommending agency is to make a referral to the appropriate agency.

(B) Swimming pools.

(1) Are to have a barrier on all sides.

(2) Are to have their method of access through the barrier equipped with a safety device, such as a bolt lock.

(3) Are to be equipped with a life saving device, such as a ring buoy.

(4) If the swimming pool cannot be emptied after each use, the pool is to have a working pump and filtering system.

(C) Hot tubs and spas are to have safety covers that are locked when not in use.

(D) Outdoor recreation equipment on the grounds of a foster home shall be maintained in a safe state of repair.

E) Outdoor areas on the grounds of or immediately adjacent to a foster home which are potentially hazardous to a foster child placed in the home shall be reasonably safeguarded, considering the age and functioning level of the foster child. Such areas include, but are not limited to:

(1) Water areas, including lakes, ponds, rivers, quarries and swimming pools.

(2) Open pits and wells.

(3) Cliffs and caves.

(4) High-speed or heavily traveled roads.

(F) A foster home shall be adequately heated, lighted and ventilated.



## RULE REVIEW CONTINUED..

(G) The following are to be stored in a safe manner that prevents the child's access, as appropriate for his or her age and development:

- (1) Bleach.
- (2) Cleaning materials.
- (3) Poisonous or corrosive household chemicals.
- (4) Flammable and combustible materials.
- (5) Potentially dangerous tools or utensils.
- (6) Electrical equipment in or on the grounds of a foster home.
- (7) Machinery in or on the grounds of a foster home.
- (8) Alcoholic beverages.

(H) A foster home shall comply with the following requirements regarding weapons:

(1) The following weapons kept on the grounds of or in a foster home shall be stored in an inoperative condition in a locked area inaccessible to children:

- (a) Firearms.
- (b) Air rifles.
- (c) Hunting slingshots.
- (d) Any other projectile weapon.

(2) All ammunition, arrows or projectiles for such weapons shall be stored in a separate locked space.

(3) Any foster caregiver who is also a law enforcement official and can document that their jurisdiction requires them to have ready and immediate access to their weapon shall be exempt from the requirements of this paragraph.

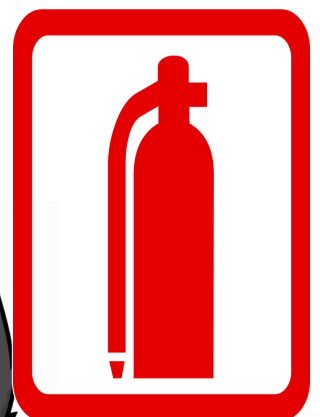
(I) A foster home shall have a working telephone or be able to demonstrate to the recommending agency reasonable access to a working telephone for emergency situations.





Please mark your calendars for the following, although your worker tries to remember it all , they sometimes fall short of your house-keeping..... These items are checked yearly

- ♦ Fire extinguisher service (serviced yearly)
- ♦ Car insurance (one to two times yearly, depends on your policy)
- ♦ Pet and animal rabies shots (due one-three years, pending your pets age)
- ♦ First Aid/CPR (due every two years around recertification)

# YMCA and ODJFS to Provide Free Memberships to Foster and Kinship Families

COLUMBUS, OHIO – The Ohio Department of Job and Family Services (ODJFS) announced today that it has partnered with the Ohio Alliance of YMCAs Foundation (Ohio YMCA) to provide free memberships for certified foster homes and approved kinship caregivers who meet certain eligibility criteria. Bridges participants and their children are also eligible.

“This is a wonderful opportunity for our resource families and the youth in our Bridges program,” ODJFS Director Matt Damschroder said. “Not only will these families be able to enjoy the benefits of exercise, but they will also be able to spend time together, enjoying the fun recreational activities our Ohio YMCAs have to offer.”

Half the cost of the memberships is paid for by ODJFS. The remaining cost, for at least one year, will be covered by an Ohio YMCA grant.

“The addition of this grant means that qualified families will have one year of free entry into Ohio YMCA facilities,” said Damschroder. “For many, this will be the first time these youth have ever had access to these types of facilities.”

To be eligible, certified foster homes must provide the YMCA a copy of the family’s current JFS 01213, “Notice of Approval for Foster Home,” showing the family is currently certified as a foster home. They must also provide a letter from the family’s recommending foster care agency on that agency’s letterhead. It must indicate the family is in good standing with the agency/state of Ohio and either the family has had at least one foster care placement within the past 18 months, or the family is a newly certified foster home within the last six months.

To be eligible as an approved kinship home, families must provide a letter from the agency that approved the family on the agency’s letterhead indicating the family is in good standing with the agency and that they have a current kinship child placed in the home.

Bridges is a program designed to help former foster youth transition to adulthood. To be eligible, Bridges participants must provide a copy of the participant’s Bridges Voluntary Participation Agreement showing the participant is enrolled in Bridges and a letter from the Bridges grantee on the grantee’s letterhead indicating the participant is currently enrolled in Bridges.

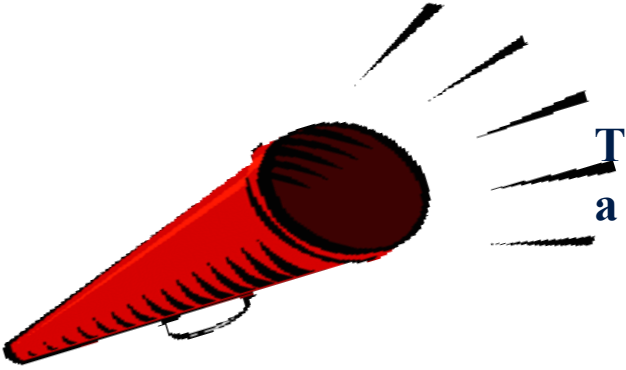
“Ohio’s 162 YMCAs are excited to partner with Governor DeWine to offer memberships to Ohio’s foster families, approved kinship caregivers, and Bridges program participants,” said Ohio Alliance of YMCAs Executive Director Beth Tsvetkoff, Esq. “YMCAs are dedicated to supporting the spirits, minds, and bodies of Ohio families. From youth wellness programs, youth sports, before and after school care, summer day and resident camp, and much more, Ohio Ys offer a variety of opportunities for kids to learn and grow.”

As part of the grant, the Ohio Alliance of YMCAs Foundation will pay/reimburse YMCAs 50% of the cost of an annual family membership for certified foster homes and kinship caregivers who meet these criteria up to \$500,000 and 50% of the cost of an annual individual or family membership for Bridges participants in Ohio who meet the criteria up to \$78,000.

*The Ohio Department of Job and Family Services manages vital programs that strengthen Ohio families. These include job training and employment services, unemployment insurance, cash and food assistance, childcare, child and adult protective services, adoption, and child support services.*

## EMERGENCY LIST REMINDERS

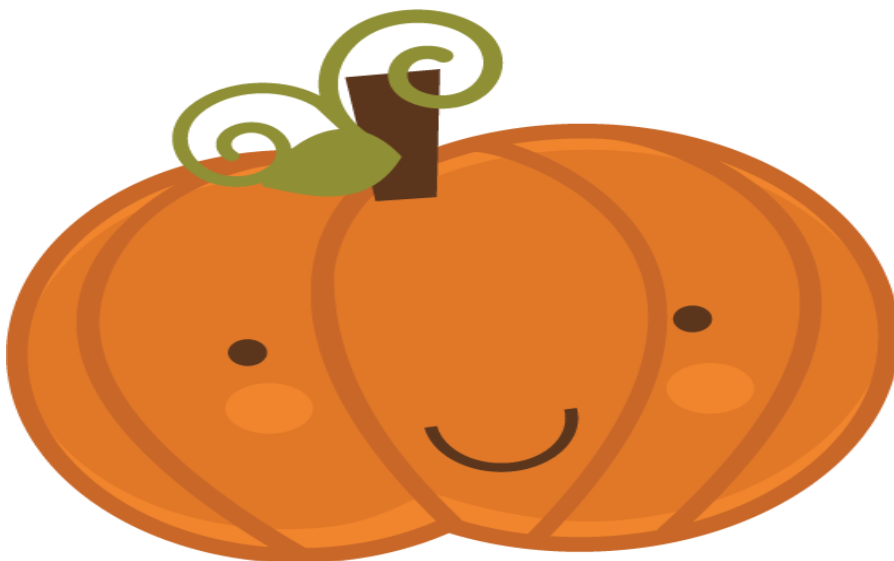

### Important things to remember when you are on the Emergency List or are considering becoming an Emergency Placement:

- ♦ This is a short term placement during an emergency crisis.
- ♦ Must answer the phone or return call to the agency representatives
- ♦ Must notify agency immediately if you are not able to continue to be on the Emergency Placement List
- ♦ Must take children sight unseen. A gentle reminder when you are on emergency, take whatever steps you feel necessary to be sure you hear your phone all times day and night. While we realize everyone is busy, it is important to know we are trying to get a child to the safest placement as quickly as possible, not answering the phone or by saying “no”, you are impeding the placement of a child.
- ♦ Placements are often made in the dark. Be sure your house is well lit and marked to make it easier for workers to find.
- ♦ Emergency Placement reimbursement is \$60/day for up to 30 days.

# CPR / FIRST AID TRAINING

## CPR/FIRST AID Requirement

Remember to register for adult/infant/child CPR and First Aid once every recertification period before your CPR/First Aid Class

This is a COA requirement for your foster care license.

All CPR/First Aid training must be an in person training. No CPR/First Aid cards will be accepted certification express from an online training.

Mahoning County Children Services CPR and First Aid policy requires IN PERSON training and skills testing for CPR and First Aid. We offer classes at the agency. These classes are through American Heart Association and cover Infant, Child and Adult CPR and AED as well as First Aid. Foster Caregivers are able to take their CPR and First Aid training anywhere they choose as long as it meets the following requirements. It must be in person with skill testing and cover Infant, Child and Adult CPR and AED as well as First Aid. It just will not be reimbursable.

Some of our foster caregivers are employed in the medical field and receive CPR training as part of employment. If this is the case, we can count the training received through employment as long as it meets the requirements listed above. We must have documentation in the form of the card or certificate issued that states all required topics were covered, including first aid training. Many individuals in the medical field receive BLS level training. This training meets the requirements for CPR, but it does not include First Aid unless it is specifically stated on the card or certificate. Due to Mahoning County's policy specifically stating in person training with skill testing is required for all of the topics discussed, failure to meet this requirement will result in a rule violation. ## IMPORTANT ONGOING TRAINING INFORMATION

Training is very important to ongoing foster parents. Because of this, the agency strives to bring you as many relevant and informative trainings as possible. Our training schedule is set by the regional offices and the expectation is we will have at least 8 participants at every training. Previous trainings have had to be cancelled due to lack of participants. Please try to attend if possible.

Please park in the garage underneath the building. The entrance for the parking lot/garage is on W. Commerce St. which is behind MCCC. Enter the lot after waiting patiently for the parking arm to raise. Drive through the lot and park in the parking garage. Enter the building through the doors on your left (non-employee doors). Take the elevator to the third floor for training. Do not park on Federal St. or try to enter from the front doors on Federal St. as these doors remain locked after hours. The parking garage will close 15 minutes after the start of training. Reminder sometimes it can be chilly in the training room, so you may want to bring a sweater or sweatshirt. Please dress comfortably.

## TRAINING REMINDER

**Please make sure when you attend a training to sign in and name the agency/county where you are from, otherwise, you may not get credit**

***REMINDER PLEASE DO NOT BRING CHILDREN TO TRAININGS***

You can earn up to 3 credit hours for reading a book; however, you must contact your licensing worker for a book review outline that is required for training credit. You can also earn 3 training hours by watching *Despicable Me*, *Juno*, *Like Dandelion Dust* or *Meet the Robinsons* and completing the movie guide. You can contact your licensing worker about getting the movie guide. Movies can be rented from your local video store, Redbox, Netflix or your local library.

**SIPS ask your licensing worker for SIPS.**

**These are supplements to help with completion of a minimal amount of training hours.**

**Each SIPS can only be completed once.**

Dear Foster Families of Mahoning County:

Mahoning County Children Services would like to inform your family of the upcoming change in the Child Welfare Training System. E-Track is being replaced by a new system, The Child and Adult Protective Services Learning Management System, or (CAPS LMS) for short. The estimated launch date for CAPS LSM is November 30, 2022. No trainings (in-person, virtual, or live synchronous) will be available from November 18<sup>th</sup> – November 29, 2022. **To receive credit for any training, including a training through Foster Parent College, the certificate for the training must be turned into your resource worker by November 10, 2022. After the launch of CAPS LSM, certificates and trainings located in E-Track will no longer be accessible.**

Please be planful in completing your ongoing training hours. This is especially true if your family will be recertifying now through the beginning of 2023. The dates listed above are only approximations and could change as this project moves forward. As Mahoning County receives updated information about the launch of CAPS LSM, your family will receive this updated information.

It has always been the Agency's goal to ensure families have ample training opportunities available to them. The training schedule for Summer/Fall 2022 is finalized, and the classes are listed in E-Track for registration. Due to the launch of CAPS LSM and an overall decline in attendance during in-person trainings, less in-person trainings might be scheduled at Mahoning County Children Services. If you are having a difficult time finding a training to meet your needs, please let your resource worker know. Your resource worker is here to help your family reach the required thirty hours of training. Please remember 15 hours is to be completed in the classroom, no more than 7.5 hours can be from training outside the classroom, and no more than 15 hours can be from online training where a trainer is present in real time.
